This position is accountable for overseeing the production, sampling, and testing of Portland Cement Concrete (PCC) and related mixtures used on construction projects within the district.

### Essential Functions

- Perform the required sampling and testing procedures for PCC mixture produced in the district and verify that all mixtures comply with contract requirements.
- Ensure that all ingredients used in PCC mixtures are from a properly inspected source and comply with pertinent specifications.
- Assist and calibrate PCC plants, mobile mix trucks and laboratory inspections assigned.
- Performs duties in compliance with departmental safety rules. Performs all duties in a manner conducive to the fair and equitable treatment of all employees.
- Performs other duties as assigned.

### Minimum Qualifications

- Completion of two years of college in civil engineering technology, pre-engineering or a job related technical/science curriculum PLUS thirty months of engineering experience; OR six years of engineering experience.

### Preferred Qualifications

- Working knowledge of materials testing and laboratory testing equipment.
- Strong oral and written communication skills.
